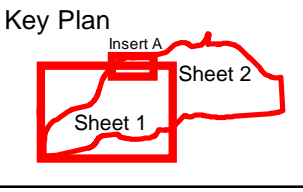
The locations of plant species protected under the Flora (Protection) Order, 1999 are considered to be sensitive data and the symbols used to indicate their locations are intentionally large so as not to disclose their exact locations.

Peregrine falcon nest sites are considered to be sensitive data. So as to not disclose their exact locations, the mapped nest/roost sites are shown as circular polygon with a 500m diameter. These circles have been randomly offset such that the nest/ roost site is not located in the centre of the polygon.
