



CUARBHÓTHAR N6 CHATHAIR NA GAILLIMHE 2018

ACHT NA mBÓITHRE, 1993 (ARNA LEASÚ) NA hACHTANNA UM PLEANÁIL AGUS FORBAIRT 2000 GO 2019

SONRAÍ BREISE SUNTASACHA A CHUR AR AGHAIDH MAIDIR LE CÁS UIMHIR THAGARTHA ABP-302848-18

De réir Alt 51 (2) d'Acht na mBóithre 1993, arna leasú, rinne Comhairle Chontae na Gaillimhe iarratas ar cheadú chuig An Bord Pleanála an 23 Deireadh Fómhair 2018 maidir le Cuarbhóthar N6 Chathair na Gaillimhe atá beartaithe.

Cuireadh Tuarascáil Measúnaithe Tionchair Timpeallachta (EIAR) agus Ráiteas Tionchair Natura (NIS) ar aghaidh mar chuid den iarratas seo.

Thaisc an t-iarratasóir freagairt ar fhaisnéis bhreise leis an mBord Pleanála an 30 Lúnasa, 2019. Meastar go bhfuil faisnéis bhreise shuntasach san fhaisnéis bhreise maidir leis an tionchar a d'fhéadfadh a bheith ag an bhforbairt bheartaithe bóthair ar an timpeallacht.

Is féidir an fhreagairt ar fhaisnéis bhreise, chomh maith leis na cáipéisí iarratais bunaidh, EIAR agus NIS a scrúdú saor in aisce nó a cheannach ar tháille shainithe a íoc le linn uaireanta oscailte poiblí ar feadh tréimhse 5 seachtaine ag tosú an 20 Meán Fómhair, 2019 sna hionaid seo a leanas:

Is féidir aighneachtaí nó tuairimí i ndáil leis an bhfreagairt ar fhaisnéis bhreise a dhéanamh ach amháin chuig An Bord Pleanála (An Bord), 64 Sráid Mhaoilbhríde, Baile Átha Cliath 1, maidir le:

- Na himpleachtaí a bheidh ag an bhforbairt bheartaithe bóthair ar phleanáil chuí agus ar fhorbairt inmharthana.
- Na tionchair is dócha a bheidh ag an bhforbairt bheartaithe bóthair ar an timpeallacht.
- Na tionchair mhóra is dócha a bheidh ag an bhforbairt bheartaithe bóthair ar láithreán Eorpach, má théitear ina bun.

Ní mór táille €50 a bheith le gach aighneacht/breithniúchán (seachas i gcás roinnt comhlachtaí forordaithe). Níl aon táille i gceist le haighneacht a chur ar aghaidh do páirtithe/ daoine aonair a bhfuil aighneacht bhaill déanta acu i scríbhinn chuig an mBord cheana féin maidir leis an iarratas. Ní mór aighneachtaí nó tuairimí a bheith faighte ag an mBord tráth nach déanaí ná 5.30 i.n. an 25ú Deireadh Fómhair, 2019. Ní mór don fhaisnéis seo a leanas a bheith sna haighneachtaí/breithniúcháin:

THE SUBMISSION OF SIGNIFICANT ADDITIONAL DATA IN RELATION TO CASE REFERENCE NUMBER ABP-302848-18

In accordance with Section 51 (2) of the Roads Act 1993, as amended, Galway County Council made an application for approval to An Bord Pleanála on the 23rd October 2018 in relation to the proposed N6 Galway City Ring Road.

An Environmental Impact Assessment Report (EIAR) and a Natura Impact Statement (NIS) were submitted as part of this application.

A further information response was lodged by the applicant with An Bord Pleanála on the 30th August 2019. The further information has been deemed to contain significant additional data in relation to the likely effects on the environment of the proposed road development.

The further information response, together with the original application documentation, EIAR and NIS, may be inspected free of charge or purchased on payment of a specified fee during public opening hours for a period of 5 weeks commencing on the 20th September 2019 at the following locations:

Submissions or observations in relation to the further information response may be made only to An Bord Pleanála (The Board), 64 Marlborough Street, Dublin 1 relating to:

- The implications of the proposed road development for proper planning and sustainable development.
- The likely effects on the environment of the proposed road development.
- The likely significant effects of the proposed road development on a European site, if carried out.

Any submissions/observations must be accompanied by a fee of €50 (except for certain prescribed bodies). There is no fee required to make a submission for those parties/individuals who have already made a valid written submission to the Board regarding the application. Submissions or observations must be received by the Board no later than 5.30 p.m. on the 25th October 2019. Such submissions/observations must also include the following information:

- The name of the person making the submission or observation, the name of the person acting on his or her behalf, if any, and the address to which any correspondence relating to the application should be sent.
- The subject matter of the submission or observation, and;
- The reasons, considerations and arguments on which the submission or observation is based in full.

Any submissions or observations which do not comply with the above requirements cannot be considered by the Board.

A person may question the validity of a decision by the Board by way of an application for judicial review under the rules of the Superior Courts (and in particular Order 84 of the Rules of the Superior Courts contained in S.I. No. 15 of 1986, as amended) and in accordance with section 50, 50A, and 50B of the Planning and Development Act, 2000, as amended.
